EXHIBITION HEALTH REQUIREMENTS FOR POULTRY,

OUT-OF-STATE POULTRY

19. All poultry, which includes game birds, quail, pheasants, peafowl, turkeys, and waterfowl shall have originated from a US Pullorum clean flock or have had a negative pullorum test within ninety (90) days of entry. All turkeys shall also have originated from a US MG clean flock or have had a negative MG test within thirty (30) days of entry. All the preceding information must be documented on a valid certificate of veterinary inspection, NPIP flock certification form or similar certificate. These forms must indicate that the flocks from which the eggs or chicks originated have been tested for pullorum disease and were free of reactors; or, any eggs or chicks or poult produced under the supervision of the National Poultry Improvement Plan will be deemed to have met with the requirements of these regulations, provided all of the requirements of NPIP are complied with and applicable NPIP forms accompany birds. All non-certified poultry must be individually identified, either by a permanent leg or wing band or tattoo. Wraparound plastic bands are not acceptable. NPIP certified flocks of turkeys, chickens, and domesticated fowl entering on a VS 9-3 or NPIP flock certification form or similar certificate are exempt from the requirement of a certificate of veterinary inspection unless a state of emergency has been declared.

ARKANSAS POULTRY

An official representing the exhibition shall notify the state veterinarian no later than thirty (30) days prior to the exhibition, giving names, place, inclusive dates, and time of the event. The requirements are as follows:

19. All in-state poultry, which includes domesticated game birds, quail, pheasants, peafowl, guineas, and turkeys, present at exhibition in Arkansas shall have originated from U. S. Pullorum-Typhoid Clean or equivalent flocks or have had a negative pullorum-typoid test within ninety (90) days of the movement to the exhibition (pullorum-typoid testing on fairgrounds during the fair is prohibited.) This information will be documented on a NPIP Form VS 9-3, 90-Day Certificate, NPIP Flock Certification Form or similar certificate that will accompany the poultry during exhibition.
2. All non-certified birds must be banded (leg or wing band), with a sealed band. Wraparound plastic bands are not acceptable. In-state waterfowl are exempt from pullorum-typoid requirements.
3. Any poultry showing evidence of infectious or contagious disease or insect infestation will not be permitted to exhibit.
4. Record Keeping – The sponsor of the exhibition shall compile a list of all poultry present at exhibition. This list shall contain the name and address of each owner, the number, the species, breed, variety, type, sex, and pullorum-typoid status of all poultry present. A copy of this shall be retained by the sponsor of the exhibition for at least twelve (12) months.

RULES AND REGULATIONS OF THE SHOW

This Poultry Show Will Provide Classes for all APA and ABA Recognized Standard Breeds of Poultry and Waterfowl.

All Birds must meet Arkansas Livestock and Poultry health requirements!

1. All birds will be examined as they are cooped in and during the show. NO sick or diseased birds will be permitted to show.
2. Sebastian County Fair Association will provide a breed club national table free of charge. All other Breed Club meets tables can be rented at 50.00 a table. Tables include two chairs. Vendor tables available, contact Kevin Jones.
3. Neither Sebastian County Fair Association, nor its club officers will be responsible for any loss, sickness, or injury to any bird brought to the show; however, all precautions will be taken to protect the exhibits.
4. APA and ABA Rules will govern the judging of the show unless otherwise stated.
5. All Protests must be made in writing accompanied by a 500.00 deposit made to the Sebastian County Fair Association. The Show Committee will make the Final Decision. In the event the committee finds no justification for the protest, the fee will be forfeited. No Birds will be weighed at this show.
6. No person will be allowed in the aisle during judging or will be allowed to talk to the judge while he is judging Except for Show Personnel.
7. All eggs laid during the show, unless gathered by the owner, will be broken as they are collected by one of the show officials.
8. Exhibitors may place sale signs on their birds' coop after judging is completed. **No sign may interfere with another exhibitor's adjoining coop.**
9. Definitions: Cock: Male bird over one year old. ~ Hen: Female bird over one year old. ~ Cockerel: Male bird under one year old. ~ Pullet: Female bird under one year old.
10. All birds will be judged through fifth place.
11. The competition is open to poultry exhibitors of the world.
12. Sale Spaces -contact Kevin Jones.
13. **By entering our show you release Sebastian County Fair Association from all Liability from Injury or Illness.**
14. **Make all checks payable to SCFA.**
15. Any Other Issue not covered in this catalog will be decided by the Show Committee.
16. All Runner ducks will be Judge in a ring, Owners need to be present to handle their birds, HOTOPA is not responsible if a bird is injured during movement.
17. **There is a Mandatory Clean Up Fee 5.00 Per Exhibitor! No Exceptions**
18. All Muscovy drakes will be Cooped in a double coop to accommodate their size at the \$8.00 entry fee.
19. All Entry Fees, Once Entered are Non-Refundable, Unless the Show is Cancelled.


